# February Finances

Income & Expenses: The net loss for February 2016 is \$548 while February 2015 posted income of \$1,740 - the difference caused by 2016 Revenues and Expenses being respectively under and over the prior year period..

Revenues are down in February 2016 by \$1,186 (11.3%) over February 2015 This is due to Membership Dues down by \$1,125 for the month but are only down by \$95.00 for the first two months of the year.

Expenses are higher in February over February 2015 by \$1,139 due primarily to \$548 over in Director Fees, \$223.15 in Club Supplies and \$288 in Printing & Office Supplies due to the purchase of a new printer (a member donated funds last year and just now purchased). Expenses YTD are over by \$2,849 due to the above and \$1,300 spent in January for the environmental testing done by Armstrong Labs.

Cash on Hand was \$80,439 at the end of February,2016 compared to \$79,346 at February,2015 – a gain of \$1,003.

Table Count: The table count for February 2016 was 355 tables with YTD table count at 768 as YTD compared to YTD table count in 2015 of 693 - a gain of 75 tables.
