# MINUTES OF THE MEETING OF THE BOARD OF DIRECTORS NOVEMBER 26, 2018

#### Minutes

# **Treasurer's Report**

Studio operations showed a monthly deficit of about \$300 and the Unit had a deficit of approximately \$2000. Cash on hand was up slightly, to over \$54,900.

# **Old Business**

The Directors allocated responsibilities for bringing items to the dinner that will be served following the December Board meeting.

The Directors decided it was time to print a new Unit Directory. D. Pearlman will format, J. Montgomery will oversee printing.

## **New Business**

The Board allocated responsibilities for the December 22 Unit game and Christmas party. Canned goods will be collected. The Board agreed they would be donated to the Crowley House of Hope. L. Spangler will contact the Unit webmaster to get the needed information on the Unit website.

D. Pearlman reported that he would very soon begin work on the 2019 Unit calendar of events.

L. Spangler noted there is a new club in the Unit, called the Bridge Club of Lewisville, Flower Mound and Coppell. D. Pearlman reported on conversations he had with the club's owner.

The Board discussed strategies for recruiting new game directors and furthering the education of existing ones. It was noted that many directors do not know how to run team games and it would be useful to have a deeper pool of directors with this ability.

The Board agreed on two individuals to receive the Unit's Goodwill Award. D. Pearlman will create writeups for use when making the presentations at the Awards Day game in the spring of 2019. The Board will also submit a nomination to District 16 for the Texas Star award.
