## **District 16 ACBL Treasurer's Report First Three Months 2013**

Attached please find the First Quarter 2013 Profit & Loss Statement, the Balance Sheet

The Profit & Loss statement shows an excess of revenues compared to expenses of \$19,405.84. This compares to a surplus of \$3,604.92 for the same time period in 2012. This was primarily due to a \$14,080 Grass Roots Fund contribution. This is the first year a contribution was received from the program.

The Balance Sheet shows that the District financial position continues to be strong. Money market rates are still extremely low so the short term CDs originally purchased in 2009 continue to be rolled over as they mature. Note that the reserve established for the next District 16 NABC event is now \$18,756.

A Budget report will be included with the Second Quarter Treasurer's Report.
