#### District 16 ACBL Treasurer's Report Calendar Year 2018

Attached is the Profit and Loss Statement for calendar year 2017 and the balance sheet depicting the financial condition of the District as of December 31, 2018.

The Profit and Loss Statement operating revenues exceeded expenses by \$29,628 The expenses of producing and distributing the Scorecard for 2018 exceeded Scorecard revenue by \$2,185 consistent with previous years' results.

Operating revenue does not reflect the NABC surcharge which is based on the Saturday attendance of the Regional tournaments held in the District. This amount is reflected in the balance sheet and included in the current NABC surcharge balance of \$20,866.

As indicated by these financial statements, the District remains in a strong financial position and is well poised to promote the game of bridge and pursue the mission of the District.
