District 16 ACBL Treasurers Report YTD September 30, 2020

Attached is the Statement of Financial Activities for the first nine months of 2020 ending September 30, 2020 and the Statement of Financial Position depicting the financial condition of District 16 as of September 30, 2020.

Normal operations for the first nine months generated revenues in excess of expenses by \$12,919. The Scorecard incurred expenses in excess of revenues by \$1,790 for the same period. There is \$5,205 of taxes and penalties that was assessed by the IRS for a late return in prior years. That is being appealed at the moment. The Scorecard results were impacted by the waiver of over \$1,000 of announcement fees related to tournaments cancelled due to COVID-19. The normal Scorecard publication was suspended after the April issue.

The District provided \$3,000 to Units that qualified and requested it for support during this Covid-19 crisis. \$500 went to each of the following Units:

172 - San Antonio

183 - Fort Western

197 – Llano Estacado

207 - Texas Capital Bridge Association

225 - East Texas

254 - San Miguel de Allende

At the end of the first nine months there was \$6,222 in the District's primary cash account, plus \$3,078 in the Scorecard bank account, and an additional \$185,114 in an interest earning Vanguard account, for total cash assets equaling \$194,415.

There remained \$35,493 of unused Grass Roots funds to be used for the future promotion and support of the GNT and NAP events. There is also \$27,838 earmarked for use in future D16 NABCs.

As evidenced by these financial statements, the District is in a strong financial position and is in good standing to continue its mission.
