What Is a Cue Bid?

An artificial bid of a suit that has been bid by the opponents, in which you do not intend to play.





Three Ways to Use Cue Bids:

- To Raise Partner's Suit
- To Show a 2-Suited Hand
- To Show/Ask for a Stopper






Using a Cue Bid to Raise Partner's Suit

- Shows a limit raise or better (10-12+ HCP) with 3+-card support for partner's suit
- Often forces partner to the 3-level when they are the opener
- Usually lets partner get out at the 2-level when they are the overcaller





Examples—North is the Opener





Example: 1 - 1 - 1 - 1 - 2



 Cue bid 2♣ for a 3-piece raise and 2♠ for a 4-piece raise!





Jump Cue (3-Level)

- A 4+-piece "mixed raise" (7-9 HCP)
- Stronger than a pre-emptive raise--has some defensive value
- Weaker than a limit raise
- Used in response to partner's overcall

Example: 1 - 1 - 1 - 1 - 2



- Bid 3♣—jump cue
- Note that 3^A would be a splinter!





Using a Cue Bid to Show a 2-Suited Hand— Michaels Cue

- Generally, made in the direct seat after opponents open the bidding
- Your partner has not bid
- Promises 5+ cards in each of two unbid suits
- Gets two suits into a competitive auction with one bid





Michaels Cue

- 1♣ 2♣ : 5/5+ Hearts and Spades
- 1♦ 2♦ : 5/5+ Hearts and Spades
- 1♥ 2♥ : 5/5+ Spades and a minor
- 1♠ 2♠ : 5/5+ Hearts and a minor
- To find our partner's minor after 1♥ 2♥ or 1♠ - 2♠, bid 2NT





Michaels Cue—Mini/Maxi

- Use the Michaels Cue for hands from 6-11 HCP or 16+ HCP
- Bid your suits separately for hands from 12-15 HCP
- If not playing mini/maxi, use the Michaels Cue for all ranges of hands





Michaels Cue—Partnership Agreements

- Will you play Michaels Cue in the pass-out seat?
 Example: 1♣ P P ??
- Will you play mini/maxi, or use the Michaels Cue for all ranges of hands?
- Will you use the Michaels Cue if you are 5/4?





Using a Cue Bid to Show/Ask for a Stopper

General Rule:

- When the opponents have bid one suit, a cue bid "asks" for a stopper
- When the opponents have bid two suits, a cue bid "shows" a stopper





Western Cue--Asking for a Stopper

- Made at the 3-level
- The opponents have bid one suit
- Asks partner to bid 3NT with a stopper





Example: N E S W 1 - 1 - 1 - 2 - 2 **3♥** - P - ??

RESPONDER (SOUTH): ▲ K 8 6 5 4 ♥ A 3 ◆ J T 4 2 ♣ 9 4

• Bid 3NT with a Heart stopper





Example: N E S W 1 - P - 1 - 2 = 23 **♦** - P - 3 **♥** - P

• Bid 4 to deny a Heart stopper





Showing a Stopper--The Opponents Have Bid 2 Suits

 2^A promises a Spade stopper, and asks partner to bid NT with a Diamond stopper
