Good news and bad news for District 16 at the summer NABC in Washington. The good news: one national title and four second-place finishes. The bad news: (only) one national title and four (close) second-place finishes. Are you a glass-half-full or a glass-half-empty type?

I'm willing to bet George and Carolyne Fox of Manvel have *their* glasses filled with champagne to celebrate their victory in the 0-5000 Life Master Pairs. They played steady bridge for three days, rising from 32nd place (out of 194 pairs) after the first round, to 16th after the second, then to the top. Let's raise our glasses (whether half-full *or* half-empty) to them!

Hemant Lall of Dallas was second in the Life Master Pairs. The LM Pairs is no ordinary pair event—it's one of the two premiere pair games on the NABC calendar (the other is the Blue Ribbon Pairs at the fall nationals). The "LMs" and "Blues," as they are known are three-day events; the field is cut in half on each succeeding day. Competing against 378 of the best pairs in the world, Hemant and his partner barely made the cut the first day (they ranked 154/156 pairs qualifying for day two!), but they turned up the heat on days two (rising all the way to 14th place) and three. Kudos to Hemant for his perseverance!

Eddie Wold of Houston captured second place in the Open Swiss Teams on the final Sunday. What a great way to end the tournament. Eddie's been on a roll, having won the North American Swiss Teams at last fall's NABC. Here's hoping it continues. Now if I could just get Eddie to play with me....

Shawn Quinn of Richmond and

Peggy Sutherlin of Dallas were runners-up in the Wagar Women's Knockout Teams. The Wagar attracted only 14 teams this summer, but what teams they were! Twelve of the top 20 women players in the world participated in the event, so coming in second was no small accomplishment. Tobi Sokolow of Austin was 3/4. Shawn and Peggy are representing the U.S. in the Venice Cup in Brazil, in September. (So is Lynn Baker of Austin, on a different team). I'm sure you all join me in wishing all three of them the very best of luck in Sao Paolo.

In the Grand National Teams, our Flight C team-- Brett Elliott, Harry Elliott, and Robert Reichek of Houston, Herbert Kalman of Bellaire, and Byron Elliott of Katy-- did District 16 proud. They made it all the way to the finals, but had to settle for second place. Great showing, guys! Keep up the good work.

Numerous District 16 players made the top ten in national events. In the Grand National Teams Championship Flight, Dan Morse, Houston, Ira Hessel and Greg Hinze, San Antonio, and Nagy Kamel, Plano, finished 5/8. Greg and Nagy were seventh in the Fast Pairs as well. In the Grand National Teams Flight B, Peter Hudson, Coppell, J. and Pamela Wiegmann, Lewisville, and David Farris, Austin, were 5/8. David Sokolow, Austin, took fifth in the 0-5000 LM Pairs. In the Mixed Board-a-Match Teams, Sally Wheeler and Buddy Hanby, Spring, finished seventh, while John Sutherlin. Dallas, and Tobi Sokolow were eighth. In the Open Swiss Teams, Ira Hessel was eighth, and John Mohan, Huixquilucan, Mexico, ended up ninth. In the Spingold, Bob Hamman, Chris Compton, and Bart Bramley, all of Dallas, and Eddie Wold were 9/16 as were Catherine and Hugh Miller, Houston, and Milton and Becky Ellisor, Spring, in the Mini-Spingold II. Finally, Gary Cox, Georgetown, took sixth in the National 199'er Pairs. Congratulations to each and every one of you!

The fall NABC will be held in San Diego from November 26 to December 6. It starts Thanksgiving night, so you can enjoy a hearty holiday meal at home with your loved ones before heading to San Diego for bridge. The venue is nothing short of spectacular, looking out as it does over the Pacific Ocean; yet, it's just a few blocks from San Diego's historic Gaslamp Quarter, which is chockablock with bars and restaurants of all types. And, of course, it's a whole lot warmer than Boston, site of last year's fall NABC. I guarantee you'll have a great time. (Note: This guarantee is void where prohibited. 

Washington Report

District 16

Our CEO Jay Baum reported we had gained 1421 new members the first half of the year. He thinks we could possibly add another 1400 by year's end which would make 2009 a great year for membership. Retention of members has been good at over 60%. Here in District 16 we have done our part with a significant increase in membership. We think 2009 will match 2008 and likely exceed it in the number of tournament tables

Dee Wallace, the new CFO, has come on board and I have high expectations for her.

The Youth NABC held at the Washington National was a huge success with many youngsters from all over attending.

The ACBL completed the lease purchase of a new headquarters in Horn Lake, Mississippi. We are starting build out and hope to move in about 6 months. Horn Lake is only about 10-12 miles from the Memphis airport. I expect this to be a showplace with an expanded Library and Hall

of Fame that will be very interesting for members to visit.

The 2010 World Championship will be held in the US Oct 1-16 at the Marriott Hotel in Philadelphia PA. This will be the Open World Championship that is held once every 4 years, so plan on attending as it will be quite a while before you will have another such opportunity.

The ACBL website has a new link called NABC Winners where interested members can look up by name or event winners of all our past NABC events.

The ACBL again voted to make the first Saturday night at the Nationals dress-up night. Players are encouraged to participate.

Any member who pays his dues within 90 days after his membership paid-through date shall have his masterpoints recorded free of charge. Such dues payments are credited from the original paid-though date, and no break in membership will be recorded.

A committee was formed jointly with management to examine and suggest changes to the relationship of clubs and management. Anyone with suggestions can e-mail them to me.

In addition to the ACBL financial report which is annually published in the ACBL bulletin, the ACBL financial report presented to the Board of Governors at the Nationals will be published on the ACBL website no later than one week after the conclusion of the Spring NABC.

The 6 session Platinum Pairs will start in March 2010 and the Silodor Open Pairs will be moved to Thursday-Friday (before the last Cont. page 16 Morse

Mexico Defeats Canada for Bermuda Bowl. Morse, Sutherlin, Wolff, Passell Qualify in Seniors

Mexico overcame a 48 IMP deficit in the final 16 boards to earn a 15 IMP victory over Canada and qualify for the Bermuda Bowl. The team of Billy Marshall, Enrico Pagani, Mauricio Smid, and Gonzalo Herrera will represent Mexico in Brazil starting Aug 29.

In the Senior trials both US reams will contain D16 players. Dan Morse, playing with former D16 stalwart Bobby Wolff, is on a team that captured the USA1 spot. John Sutherlin will be on the USA2 team along with Mike Passell.

In a 128 board playoff Mexico got

off to a 51 IMP lead after the first 16 board segment but was down 48 with 16 hands to go. Needing volatile hands they got what they wanted and scored 5 slam swings. Only one was bid by the Canadians and they went down on that one. One of the swings was a 26 point grand in which the Northerners stopped in game!

The Bermuda began on Aug 29 and should be well on its way to completion by the time this issue will be delivered. You can catch all the action on bridgebase. District 16 should be proud that 6 of the 7 ACBL representatives contain players from our District.

What a wonderful tournament was had at Washington this Summer. Tournament Chair, Margot Hennings, and her assistant, Fred King, did a Super Job!!

Washington D.C. is a very exciting city with many things to do, like visiting the White House, Pentagon, the Smithsonian Museums, Congress, U.S. Supreme Courts, etc., etc. There was something for everyone, when not playing bridge. The city reminds me of Paris, France.

The last Washington Summer NABC in 2002 had a total of 14,650 tables and this Summer we had a total of 14,115.

The new ACBL President elected by Board of Directors for 2010 is Richard DeMartino from District 25.

Finding a bridge club in a city you might be visiting: The ACBL's web page now has a place called: "Find a Club". This new feature helps bridge players find a club in the United States and Canada by using the name of the city or the zip code/postal code. It will give you the address of the clubs, contact persons, telephone numbers and a map to use. This feature should come in very handy for our bridge travelers!!

Monitoring by live cameras: The ACBL will be monitoring NABC events with real-time cameras. This information will be stored to be used in case of appeals at the

table.

NO Phones: "Cell phones, audible pagers or any similar communication equipment may not be operated or operable in the playing area during a session of play at NABC's except health-related equipment or by permission of the director-incharge of the tournament or event."

Spingold Top Seed Team falls because of a telephone in the playing area: A cell phone was the downfall of the No. 22 seed as they incurred a 12 imp penalty for the infraction of the telephone which caused them to lose a close match.

Membership: The ACBL reflects a significant increase in membership partly because of the Amnesty Program and the new Life Master Requirements which will be in effect in January 2010. The requirements are modified to include earning 500 points, of which 250 points must be pigmented as follows:

- 50 must be gold or platinum
- 50 must be red, gold, or platinum
- 75 must be silver
- 75 must be black

The Texas Star Service Awards will be presented on Saturday before the evening session at the Houston Regional in February 2010.

If your Unit decides to so honor one of your members for 2006, please initiate the process within your Unit. After your selection is made, send us a letter outlining your designee's contributions to your Unit, a brief personal sketch, and, if possible, a photograph suitable for publishing in the *Scorecard*. We must receive all this information by January 1, 2010

This is a great way to say "thank you" to a member who has worked hard in behalf of the Unit.

<u>Please keep your selection secret as surprise is an important part of the Award presentation.</u> Feel free to call if you have any questions.

TEXAS STAR AWARDS

Description of the Award & Guidelines for Selection and Presentation Ceremony

- 1. The Texas Star Service Awards ("the Awards") shall be presented once annually at the Lone Star Regional Tournament held in Houston in the winter.
- 2. The Awards shall be presented by the President of District 16. If for any reason that officer is unable to make the Presentations, he Texas Star Service Awards Committee shall select a person to make the presentation.
- 3. The Awards shall be presented just prior to commencement of play of the second session of the game on Saturday. If play is held in more than one location, a presentation ceremony shall be held in each location. Presentation of the Awards shall be shown on the printed schedule of the tournament. Sufficient time for the presentation shall be allowed by the Director in charge of the tournament.
- 4. Identity of the recipients of the Award shall be kept secret until their names are announced by the presenter during the presentation ceremony. All persons involved in the selection process at both the Unit and Committee levels shall take every precaution to insure confidentiality from commencement of the selection process until after presentation of the Awards. The method, screening and selection process shall not be discussed by any person involved except among themselves.
- 5. Each Unit within District 16 may, but need not, select one person to receive the Award annually. A married couple may be selected. Each person selected shall be a member of the selecting Unit in good standing, resident within District 16. A person who has received the Award in a prior year is not eligible for selection.
- 6. A recipient of the Award shall be a volunteer who has worked diligently at the Unit level. Receipt of a nominal compensation for burdensome tasks shall not automatically classify a person as a non-volunteer. A unit may ask the Committee to determine the classification of a potential recipient of the Award. The Committee's determination of classification of a potential recipient shall be final.
- 7. The Committee and its Chair shall be appointed by the President of District 16 at the annual meeting held during the Lone Star Regional Tournament in Houston at the beginning of each calendar year. The President may appoint the Jacoby Award Committee and its Chair to form the Texas Star Awards Committee ex officio. The Committee shall receive the selection from the Units annually, and arrange for a suitable commemorative pin for each recipient of this Award.
- 8. The Chair of the Committee shall notify each Unit each September of the opportunity to name a recipient of the Award. Such notification may be by letter or by publishing the notice in the Scorecard. The notice to the Units should outline the qualification which the Unit should keep in mind in making its selection and should stress the need for confidentiality. Selections by the Unit must be received by the Committee by January 1 of each year.
- 9. The Committee shall maintain a record of all recipients of the Award

John Fisher 1925-2009

John Fisher passed away Aug 14, 2009. John won 9 national championship and had 8 seconds. A major force in bridge in the 60's and 70's he won the McKinney Trophy (most masterpoints) in 1972. We thank Terry Radjef for a personal remembrance.

I have lost my best friend. John, as he liked to be called by his close friends, left us Friday August fourteenth. He found out in June that he did not have much longer to live. We had a party hosted by Jeanne Kretz for his birthday July fifth. For many, it was also a goodbye. We had our private one to each other at his house three weeks ago. I brought lunch from 'La Madeleine' where we used to meet often to talk bridge and about things of mutual interest. He had been my primary care physician from 1980 to 1993 when he retired, and the best bridge partner I ever played with.

We played in his last three Silver Ribbons finishing a respectable seventh, eleventh and twelfth. His bridge accomplishments are well known. He won nine national championships As a world competitor, in addition to being a Grand Life Master with more than 19,000 master points, he was also a World Bridge Federation Life Master. His most amazing feat was winning the McKinney Trophy (most masterpoints) in 1972 while maintaining a full time schedule running his 'one doctor practice' in Dallas. Barry Crane was his bridge manager for that year and John credited him for

being the 'slave driver' that led to his success. He loved playing part scores and milking every ounce out of the hands. He was reknown for being slow, but he won a Fast Pairs event in a New Orleans National. No kidding!

John was born on a farm outside Carrollton, Texas where he went to Dewitt Perry High School, now a middle school. From there he started an illustrious career in the medical field, graduating second of his class, being a Major during the Korean War and establishing his practice in the early fifties downtown Dallas.

I will never forget his kindness and genuine concern when taking care of me as his patient. He also was a great bridge partner to all that played with him. A calming comforting influence on those that have been lucky enough to be in his life. He can't be replaced. Texas has lost a giant of a man, not just a great bridge player.

Tournament Managers Workshop

By Paul Cuneo

I attended the Tournament Managers workshop at the NABC in Washington on July, 24. The discussion focused primarily on Regional Tournaments with very little time spent on Sectionals. Ken Monzingo did an outstanding job. The following is a list of the ideas I picked up which may be of use within District 16.

- 1. Some Districts require each Regional Tournament to make space available for advertising upcoming District Regional Tournaments in their Daily Bulletins. Many said this was ½ a page twice during the Regional for the next Regional in the District.
- 2. The Professional Convention
 Managers Association offers many
 FREE resources to help us understand
 the mindset of the Hotel people we
 are negotiating with. Also free contract forms.
- 3. Last minute room night attrition

is becoming a bigger problem as the hotels compete with the Bridge Rate by offering lower rates through websites such as Orbitz and Priceline. Tournament Managers should obtain a list of players from the DIC and ask the hotel to compare that list with those who had rooms during the tournament for the room guaranty. Logic is the Bridge Tournament brought them to the hotel regardless of the price they paid.

Gold Rush Pairs – New England offers this event at its regionals. It is a 2 session event where 0-750 play together with stratification of 0-300 and 300-750. There is also an Open Pairs 2 session event at different times that gets "credit" for the Gold Rush pairs when calculating masterpoint awards. The Open Pairs are Flight "A" and "AX". http://

Many Districts mail postcards to their I/N players INVITING them to attend the Regionals. They find this increases I/N table count.

Why I play Bridge by George Fillis

- delight in the people who play to get better and progress in their knowledge and understanding

The stimulation has come not from just the game but the players, people who are motivated to progress on a learning curve, who have the generosity to share their knowledge and passion for the game they have enjoyed for so long with those who are just now becoming addicted.

In playing the game on-line and being at a table with people from all corners of the world, it becomes evident that bridge is a universal language that transcends cultures and spans generations.

The game is wonderful, but the game is made of people who play for the pursuit of gamesmanship, camaraderie and companionship.

Instructions for Submitting Photos

- 1. Use a flash to insure adequate lighting.
- 2. Choose a background that does not have distractions.
- 3. For team photos, have the two tallest members sit down, and the two shorter members stand behind them. Ask the ones standing to lean in a little so everyone will be in focus.
- 4. Center your photos, so no cropping will be necessary later.5. Have the players write their names, the date, and the event they

won on a sheet a paper. Have them write their names as they are positioned in the photo: left, right. For team photos: left rear, right rear, left front, right front.

6. After downloading the photos on the computer, rename the photos by the players' last names as they appear in the photo. For example: Hamman-Wolff for a pair; or Meckstroth Rodwell Nickell Freeman using the format left rear, right rear, left front, right front for teams.


