## **Tom Corlett Wins 2010 Jacoby Award**



Congratulations to Tom Corlett, from Unit 233, the winner of the 2010 Oswald and Jim Jacoby Service Award. District 16's premier service award was established in 1982 to honor those volunteers who have worked diligently at the Unit level and have risen to recognition at the District level after many years of outstanding service.

During any given week Tom actively teaches bridge lessons for 30 minutes before regularly scheduled club games, playing in every available club game (often with novice players who love the chance to play with him), and in every possible sectional and regional tournament in Texas and beyond, and attending almost every NABC.

At every tournament associated with District 16 Tom can be seen encouraging novice players as well as others and eagerly introducing newer bridge friends to perennial tournament attendees. He is such an ambassador for the sense of camaraderie that extends among fellow bridge players whether at the club, unit, district, or national

level. He is the "go to" person for answers to questions about bridge strategy, bridge etiquette, bridge conventions, and bridge statistics. He is such a "pied piper" for this game.

Tom served a three-year term on the Unit Board of Directors from 1992-1995 serving as vice-president his first year and as president for one year. He was elected as Unit representative to the District Board of Directors for a three year term in 1997 and re-elected for two more three year terms. During this period he faithfully shared reports of meetings with the Unit Board of Directors

He co-chaired the Waco sectional tournaments in 1999, 2004, 2005, and 2006 with exemplary results.

In 2000, Tom was one of three District 16 representatives elected to the ACBL Board of Governors and has been re-elected continuously up to the present. As a member of the District 16 Board of Directors, he served as vice-president in 2003 and president in 2004. In October 2000 he was awarded lifetime membership on the ACBL National Goodwill Committee. In 2009 he was unanimously awarded the Texas Star Award for Central Texas Bridge Unit 233.

Tom Corlett represents all that the District 16 Jacoby Award stands for in offering service, support, expertise, and love of the game from the smallest unit game to the largest tournament in District 16 and beyond.

For thirty years I was in a leadership position with the public schools in Texas, and during the past ten years, I have taught leadership courses at the university level. Good leadership skills are necessary in businesses, schools, and organizations such as bridge units and districts. Let's consider some of these qualities as we choose our next unit officers, tournament chairpersons or others in leadership roles.

David Hakala (HR World, March 2008), identified ten essential leadership qualities. This month we will discuss these qualities.

A leader should have a clear **vision** of where the organization should go and how to achieve its goals. This would include helping the organization establish goals and action plans and communicate the goals to all the stakeholders. In other words, effective leaders get everyone on the same page and working together. Communication is critical. Are items clearly stated or is there a "failure to communicate?"

Integrity and dedication are also essential. These characteristics might be observed through organizational skills. Are appointments made in a timely manner? Are agendas provided at the last minute or several days ahead? Is the organization always trying to catch up? Are meetings productive due to preplanning and effective leadership skills? Effective leaders are magnanimous and humble. They give credit

where it is due and seek to give credit for success throughout the organization. When a true leader is asked, "What do you do?" he or she will say something like, "I work with people to accomplish the goals of the organization."

A good leader is **open** and willing to listen to the thoughts and ideas of others in the organization. An open leader never forgets that there is no "I" in TEAM! This leader is also **creative** and able to think outside the box. Hakala states that the most important question a true leader can ask is "What if...?"

Effective leaders are **fair** and gain all the necessary information before making decisions. They treat all the members of the organization in a manner that is perceived as fair. They are **assertive** and able to state expectations clearly.

Finally a **sense of humor** is essential to the repertoire of skills that an effective leader possesses. A good leader knows when and how to use humor to defuse a tense situation or to energize the group.

It is difficult to predict how someone will react in a leadership position because ego may adversely affect the effectiveness; however, in bridge we know that effective leadership will either help our membership grow -- or not! It is essential for District 16 to maintain or improve our current membership level in order to keep our five regional tournaments per year, and effective leadership can make all the difference.

As you work with your unit this year to select those in leadership positions, consider these qualities of effective leaders. Better yet, check yourself against these qualities and see if you might be just the leader that your unit needs! ## World Champions! Donna Compton Wins Mixed Pairs, Greg Hinze Wins Mixed Teams





Congratulations to Donna Compton and Greg Hinze, who each won a Mixed event at the recent World Championships in Philadelphia. Donna, playing with Fulvio Fantoni from Italy, won the opening event, the World Mixed Pairs. Her position was 124th after the three qualifying rounds; 156 pairs of the 432 entered qualified for the finals. She followed with a cumulative 57.71% in the final 3 sessions to win by close to a board.

Greg, partnered with JoAnn Sprung of Philadelphia and teammates Connie Goldberg of Philadelphia, Canadian Dan Lavee and Lynn and Dale Johannesen from Washington, won the Mixed Swiss Teams. Greg's team led after the qualifying and went into the final with full carryover. They stayed close to the lead

and regained the lead with a strong final match.

Other District 16 members had notably high finishes in other events. Bob Hamman lost a close final in the prestigious Rosenblum Cup, the only major team event he has yet to win. John Zilic, playing with Kelly Hwang from New York, took home the bronze medal for third place in the IMP Pairs. In the 15-session Women's Pairs, Georgiana Gates, paired with former longtime District 16 member Pat Norman of Colorado, placed fifth.

## Sleepless in Philadelphia

October 4, 2010 - 4:45 A.M. - Yep, looks like it's closing in on a full 24 without any shut-eye. I must confess that while on the tournament trail I normally partake in a sleep-aid medication before retiring, but was so exhausted from the six sessions (3 days) of the Mixed Pairs I'd somehow convinced myself that slipping into slumber would be a piece of cake. I was mistaken. At this point, I thought I might as well use the quiet (well, mostly quiet - my partner and roommate has a soft, even snore) to reflect on the outstanding experience of actually being in Philadelphia and competing in the 13th World Championships. Certainly hats go off to the World Bridge Federation and all of the many organizers and volunteers that it must have taken to pull off what had to be an enormous undertaking. The playing conditions were superb, starting with each table (216 in play for the 1st qualifier of the Mixed Pairs) spaced at least 6 to 8 feet apart in all directions and equipped with wooden screens and bidding trays that appeared to have just been delivered from the saw mill, crispy clean bidding boxes, predealt hands and a computerized scoring machine that was programmed to give both directions their percentage earned on the board just played. Impressively the directors kept the event running amazingly smoothly and timely. During the last round of

each set a personal summary for

each pair was placed on your table, so no needless waiting around for results. The two daily sessions were basically set up as a play-through, varying with 10 sometimes 11 A.M. starts and giving just enough time for a quick bite between sets (one to two hours), allowing for the evening to be spent at your discretion. Within minutes of the playing site were a plethora of high quality and reasonably priced restaurants and cafes of every cuisine imaginable - a very happening downtown area. (Philly will be hosting 2012 Summer NABC.) A surprising detail for me in the conditions of contest read as follows: "For the Mixed Pairs - in order to ensure that there shall be a man and a woman on each side of the screen the men shall sit North and West, the women South and East." (Everyone was wearing clothes - there was a published dress code!) My amusement continues as I've since questioned several world champions as to the purpose behind the rule. Each provided a reasonable view but to date I haven't been given the same explanation from anyone. Okay, back to 7:45 A.M. - The land of Nod still eludes - must be time to get up - need to be at the airport by 10. What remains are, of course, all the results that might have been but weren't (and I must admit there were quite a few) - but more importantly a most-positive lifetime memory. As I always say, "You just can't win if you ain't there!"
